

City of Mandan
Adopt-A-Street Agreement

This agreement is between the City of Mandan, acting by and through its City Administrator, hereinafter referred to as City of Mandan, whose address is 205 2nd Ave NW, Mandan, North Dakota 58554, and _____, hereinafter referred to as the Group, whose address is _____, who recognize the need and the desirability of litter-free street-row's and enter into this agreement to permit the Group to volunteer its efforts in maintaining litter free street-row.

City of Mandan recognizes the Group as the adopting organization for _____, from _____ to _____, and the Group accepts the responsibility to pick up liter on this section of street-row and promoting a litter-free environment in the community for a period beginning _____, 20____, and ending _____, 20____. (minimum two years).

By this agreement, the Group acknowledges the hazardous nature of litter pick up and aggress to the following terms and conditions:

- When participants are 15 years of age or younger the Group shall furnish adequate supervision by adults.
- Each Group shall conduct at least one safety meeting per year and not more than 30 days before commencing the initial work. Participants must attend such a safety meeting before participating in any work. The attachment to this agreement, "Safety Tips for Adopt-A-Street Groups" shall be covered at all safety meetings.
- The adoption period shall be for a minimum of two years.
- The Group shall pick up litter in May and September each year and such other times the Group deems appropriate.
- The Group shall obtain trash bags from City of Mandan during regular business hours.
- The Group shall place the filled trash bags just off the outer portion of the shoulder of the road for pick up by City of Mandan.
- Unused trash bags shall be returned to City of Mandan within one week of the cleanup.
- The Group shall be considered an independent contractor and not an employee of City of Mandan for any purpose, such as workers compensation, medical insurance, nor any job benefits normally provided to full-time classified employees.
- The Group and each of the participants agrees to release the City of Mandan, its agencies, officers and employees (City), from any and all claims of any nature, including all costs, expenses and attorneys' fees, which may in any matter result from or arise out of this agreement.

City of Mandan agrees to:

- Erect, as soon as feasible, a permanent sign at each end of the adopted section of the street-row with the Group's name and acronym displayed.
- Provide trash bags.
- Remove filled trash bags the first feasible workday after the pick up.
- Remove litter from the adopted section when unusual circumstances are discovered; i.e., large, heavy, or hazardous items are on the right way.

If in the judgment of City of Mandan it is determined that the Group has failed to perform it's duties, City of Mandan may terminate this agreement upon 30 days written notice to the Group, and remove the signs.
